#### **TEEN ACCUSED OF SEXUAL AS-**

SAULT: A teen has been charged with a sexually assaulting a 2-year-old girl he was babysitting in her Felton home. The 15-year-old surrendered to Delaware State Police on Oct. 5 after the child told her parents what had happened, said agency spokesman Cpl. John Barnett. Police learned that the teen had worked as a babysitter for the family several times. On Oct. 2, the child's parents had gone out for an evening dinner and left the girl and her 1-year-old sister in the teen's care, Barnett said. When they returned, the girl told them the teen had pulled down her diaper and licked her in a private spot, court records said. The Felton teen was charged with first-degree rape and committing a dangerous crime against a minor younger than 14 years old. He was released on \$35,000 bail and ordered to have no contact with anyone younger than himself.

### WWII gunnery tower Built in 1942 to aim Fort Miles batteries

Two resort-area preservation groups have joined forces to raise money for restoration of one of two World War II fire control towers just south of Dewey Beach, which they want to open to the public.

The view from 64 feet above sea level should be spectacular because from the top, people can see  $14\frac{1}{2}$  miles east over the Atlantic Ocean, said Gary Wray, president of the Fort Miles Historical Association, one of the groups involved in the project. To the west is Rehoboth Bay.

Wray's group has joined the Delaware Seashore Preservation Foundation to raise money and begin tower restoration.

The plan, said Shirley Price, a co-chairwoman of the tower restoration project, is to raise \$500,000 and refurbish the tower over the next seven years.

Actual restoration work is expected to take about six months because the tower is in remarkably good shape, said Harold E. Dukes, the tower restoration cochairman

For the project launch Wednesday, Dukes brought along a flagpole and an American flag.

The flagpole was significant because, Dukes said, his grandbecause, Dukes said, fils grand-mother used it to fly an American flag from her home on VE Day. Dukes said the groups hope to raise \$350,000 to be used for the

restoration work and an additional \$150,000 for a perpetual maintenance fund.

A structural engineer has already signed off on the stability of the tower, which was built in 1942. And the two preservation groups have an agreement with the state Department of Natural **Resources and Environmental** Control which will allow them to proceed.

"We have an opportunity now, with this project, to bring the tower back to life," Price said.

Dukes said the fundraising will focus on creating a memorial for World War II veterans. That will include sailors in the merchant marine who served in war.

The plan is to set up an interactive database to honor those who served, with the donation to enter a veteran in the database set at \$350, he said.

Fire Control Tower 3 was built in 1942 as part of a coastal defense network that was based at Fort Miles about five miles to the north at Cape Henlopen. State parks officials have already restored one of the fire control towers, but it is located within Cape Henlopen State Park in Lewes.

## **Newark mum** on officer in **DUI** arrest

Off-duty cop wrecked car leased by city for undercover purposes

An off-duty Newark police officer was arrested on drunken driving charges last month after he crashed a city-leased car on Del. 1.

Delaware State Police Cpl. Jeff Whitmarsh said the officer, 30-year-old David Young, was taken into cus-tody at about 10 p.m. Sept. 6 on southbound Del. 1, south of the Biddles Corner toll plaza.

Young crashed the Toyota Corolla he was operating into a concrete barrier, Whitmarsh said.

The vehicle was one of three leased by Newark for undercover police use, Mayor Vance Funk said.

When asked Wednesday if Young was currently working on the street, Newark police Chief Paul Tier-nan said he was prohibited from commenting.

We're not allowed by law to discuss personnel issues," Tiernan said.

Funk said Wednesday that he was aware of the incident, but that the matter had not yet been brought before City Council

"Generally, they would report it when disciplinary action is about to take effect," he said. Councilman Jerry Clifton said because it involved a

personnel issue, council was made aware of the arrest through a confidential memo shortly after the incident occurred.

He said council is separated from personnel action

by the city charter. Any action taken will ultimately fall to the city manager and city personnel director. City Manager Carl Luft did not return a telephone

call seeking comment.

"We were made aware that it happened and it's under investigation by state police," Clifton said.

Clifton said law enforcement officers, just like councilmen, are held to a higher standard in the public eye.

If it would have been a construction worker or auto mechanic, nobody would have cared," Clifton said. "The criminal process has to proceed from here. That's something I hold in high regard – a person is innocent until proven guilty." Funk said damage to the leased vehicle would be

covered by the city's insurance.

#### Judge dismisses charges against Dover teacher

Charges have been dismissed against a former Dover teacher arrested in spring for allegedly threatening to fail one of his students if he didn't give him a ride downtown to buy drugs. Jason Miller, of the state Attorney General's Office, said Wednesday that at a Sept. 18 trial in Kent County Court of Common Pleas, the judge dismissed misdemeanor charges of acts constituting coercion and official misconduct against 36-year-old Damon W. Bethel. The Attorney General's Office then filed a motion to reopen the case, but the judge denied the request Tuesday. Bethel was arrested in May after his teenage accuser was stopped by Wesley College security officers for driving erratically in downtown Dover. The 18year-old teenage told the officers that his teacher jumped into his car while he was getting gas about 1:30 a.m. at Leipsic Road and North Du Pont Highway and told him to drive him downtown so he could buy some "weed." Police located the teacher's book bag in the car along with Bethel's school faculty identification card, police said in court records. Bethel, who had been working at Dover High School for about a year, was placed on suspension after his arrest. Bethel said Wednesday he now plans to file a petition with the school for a hearing to get his job back.

#### **MOT Senior Center's 'rain** garden' earns EPA kudos

A "rain garden" at the Middletown-Odessa-Townsend Senior Center won federal recognition Tuesday for helping to control stormwater runoff through small-scale projects that preserve natural drainage patterns in watersheds.

#### Bear man's murder trial in stabbing under way

The trial of a Bear man charged with fatally stabbing a 21-year-old man last year after an argument about women is under way in New Castle County Superior Court. Deshawn D. Drumgo, 26, is charged with the June 15, 2006, first-degree murder of Larry Larkin. He is also charged with weapons offenses. Drumgo's trial began Tuesday. According to police, Larkin and Drumgo were in an argument involving two women when the confrontation escalated and Drumgo stabbed Larkin. Larkin died at Wilmington Hospital. An autopsy determined Larkin died from a stab wound to the chest. If convicted of first-degree murder, Drumgo faces life in prison.

#### EPA recognizes firm's system for recovering gasoline vapors

The Environmental Protection Agency on Thursday recognized Delaware-based Compact Membrane Systems Inc. for developing a new system to reduce emissions from gas stations

Compact Membrane's system captures 99 percent of gasoline vapors that would otherwise escape to the air from pumps and underground tanks, and is expected to help California meet clean air goals.

EPA grants totaling nearly \$300,000 helped the company verify the performance of its system and helped move it into the marketplace. On Thursday the company was awarded the Small Business Administration's Tibbetts Award, reserved for the country's best research innovations by small businesses.

Compact Membrane's technology is the only one certified for use by the roughly 11,500 California gasoline stations now facing a 2009 deadline for installation of vapor recovery systems under air quality rules adopted by that state.

The company has received about \$2 million overall from the EPA to support various research and development efforts under the SBA's Small Business Innovation Research program.
